BRIEF DESCRIPTION:

A competitive Invitation to Bid was issued to obtain pricing for 24 different types and sizes of quarry rock and sand. These products are used by the Road Maintenance Division of Public Works in their ongoing road maintenance activities.

Road Maintenance trucks pick up the rock products on an "as needed" basis during the bid term from the quarry whose pricing, when added to the hauling cost, results in the "lowest in place cost" for the rock required. The sand is delivered by the vendor to the Arlington and Cathcart Road Maintenance locations.

Nine (9) companies offered competitive pricing. Their submittals represent a total of eleven (11) gravel pit locations in Washington State. The eleven (11) supplier names are listed on page two (2).

The award of this bid will result in a two-year contract with each of the eleven (11) locations on a firm fixed price basis for picked up rock and delivered sand. The estimated annual dollar value of the rock products to be purchased under this competitive bid is \$500,000.00. The estimated annual dollar amount of delivered sand to be purchased is \$15,000.00. Sand orders will be placed on an "as-needed" basis during inclement weather such as heavy and/or prolonged snow and ice events.

AWARD AUTHORITY:


This contract award recommendation is before the County Council for approval to award in accordance with Snohomish County Code section 3.04.120, "Competitive bidding," and section 3.04.140(3) and (8), "Award, execution, by whom," which establish the County Council as the award authority for contracts subject to bidding requirements greater than \$250,000.

AWARD RECOMMENDATION:

The Purchasing Manager and the County Executive have, in turn, reviewed this award recommendation and hereby recommend approval by the County Council. The Director, Road Maintenance, Public Works, has also endorsed the award recommendation.
