Pursuant to Section 32 of the Ordinance (p. 28), the Grantee has **90 days** after approval by the County Council (**August 8, 2023**) to accept the agreement.

Following receipt of the acceptance page by the County Council, and payment of all administrative costs and fees made with the County Public Works Department, the Franchise will be recorded with the County Auditor's Office.
