PROPOSED ORDINANCE NO. 24-038

APPROVING AMENDMENT NO. 20 TO CONSOLIDATED CONTRACT WITH WASHINGTON STATE DEPARTMENT OF HEALTH AND PROVIDING AUTHORITY FOR FUTURE AMENDMENTS REGARDING INFECTIOUS DISEASE-STI PROGRAM EXPANSION

<u>Summary:</u> The ordinance approves Amendment No. 20 to the 2022-2024 Consolidated Contract between Snohomish County and the Washington State Department of Health (DOH). The Health Department receives the majority of its grant funding through the Consolidated Contract with the Washington State Department of Health. This funding is used for many different public health services including maternal and child health block grant, recreational shellfish activities, tuberculosis control, and many more. Amendment No. 20 increases funding by \$653,202 for a total consideration of \$36,493,261; and amends and adds statements of work for additional programs.

At the Public Hearing, the Council may consider amendments to the proposed ordinance.
