8	ESTABLISHING THE 2025 MONTHLY VEHICLE ALLOWANCE OF		
9	ELECTED OFFICIALS PURSUANT TO SCC 3.36.035(2)

11	WHEREAS, SCC 3.36.035(2) provides that the elected officials designated in		
12	SCC 3.36.030 who use their own vehicles for official travel or county purposes may be		
13	paid a monthly vehicle allowance at a rate established by ordinance not to exceed 99		
14	percent of the average monthly ER&R cost for replacement, maintenance, insurance,		
15	and fuel expenses of a standard size county pool vehicle as determined by the Director		
16	of Facilities and Fleet on an annual basis; and		
17			
18	WHEREAS, the Director of Facilities and Fleet reviewed the average monthly		
19	ER&R cost for replacement, maintenance, insurance, and fuel expenses of a standard		
20	size county pool vehicle pursuant to SCC 3.36.035(2) and determined the cost to be five		
21	hundred ninety-five dollars and fifty-six cents (\$595.56) for 2025;		
22			
23	NOW, THEREFORE, BE IT ORDAINED:		
24			
25	Section 1. Based upon the Director of Facilities and Fleet's determination that		
26	the average monthly ER&R cost of replacement, maintenance, insurance, and fuel		
27	expenses of a standard size county pool vehicle is \$595.56 for 2025, the County		
28	Council finds that the maximum reimbursement rate authorized by SCC 3.36.035(2) is		
29	\$589.60 (99 percent of the average monthly ER&R cost) per month.		
30			
31	Section 2. Pursuant to SCC 3.36.035(2), the Council hereby establishes the		
32	reimbursement rate for elected officials who use their own vehicle for official travel or		
33	county purposes at 99 percent of the average monthly ER&R cost or \$589.60 per month		
34	for 2025. In addition to the monthly rate, any elected official designated in SCC		
35	3.36.030 may claim reimbursement for mileage traveled by personal vehicle outside		
36	Snohomish County for county purposes at the rate authorized by SCC 3.36.020.
