Program Financials

Karen presented the program financials and credit card reports including information regarding program budget, in-kind match, current and projected spending. She expressed the importance of family participation as it relates to program match. Members asked questions relating to spending and Karen provided additional information.

Management Report

Karen presented the Management report.

- Enrollment Update
 - Program is over-enrolled at 83 with 82 available slots.
 - > There were no vacancies over 30 days.
- Staffing updates
 - An ITS full-time position was open, and the job was posted.
 - > The program hired the person who was the temporary staff to fill this position.
 - Karen shared that Early Head Start followed all the EHS and Snohomish Counties policies and procedures for hiring, giving everyone the same opportunity to apply for position.
 - Another member out on leave also resigned and this now vacant position is posted.

- Full Enrollment -Initiative Update
 - The program, has been fully enrolled every month. The program needs two more months of being fully enrolled (through November). Once the Full Enrollment Initiative is completed, the program must maintain enrollment at a minimum of eighty percent and fill vacancies within 30 days.

Update – Office of Head Start

Karen shared information regarding the current federal shutdown.

- Federal Shutdown
 - Currently no Office of Head Start staff are working.
 - > Payments are still being processed.
 - > The Program will continue to provide services through December.
 - Our program staff remain hopeful that a budget decision will be made soon, and we continue to operate as usual in January 2026.

Continuation Grant Application Process-Year 2

5-year grant award with annual continuation application with budget (2025-2029) Karen shared information about the status of the Year 2 Continuation Grant Application with budget.

- 2025 Application: Program Budget
 - Application currently pending with Office of Head Start
 - > The program is completing the first year of a five year grant cycle (January through December 2025).

- ➤ The program submitted a renewal application for the upcoming program year which begins January 2026 and if in good standing, the program is typically funded
- ➤ The program staff are remaining hopeful and anticipating there will be time for the Office of Head Start to make a decision about the application prior to end of December
