**Background:** In February of 2020 Snohomish County entered into a Software as a Service Agreement ("Agreement") with Rave Wireless for a new integrated notification system. Snohomish County selected Rave Wireless, through RFP-11-19SB, following established Federal, State and County policies to provide an "out of the box" 24 hour a day, 7 days a week support that would integrate with existing County public safety systems Sno911 and Smart911 with minimal configuration. To date there have been 3 Council approved amendments and 1 Executive approved amendment for various upgrades.
