AGREEMENT FOR PROFESSIONAL SERVICES – AMENDMENT NO.6

THIS AMENDMENT NO.6 to that certain Agreement for Fire Alarm Inspection and Maintenance Services (the “Agreement”) dated June 15, 2023, is made by and between Snohomish County, a political subdivision of the State of Washington (the “County”) and Smith Fire Systems, a Washington corporation (the “Contractor”).

NOW, THEREFORE, for and in consideration of the benefits conferred on both parties and the mutual promises set forth below, the parties agree that the Agreement be amended as follows:

1. The Facilities Department executed a contract on June 15, 2023 with Smith Fire Systems for Fire Systems Inspection and Maintenance services under RFP-22-020TB which has an expiration date of December 31, 2025. The agreement allows for two one-year extensions and by approval of Amendment 6, would approve the first one-year extension through December 31, 2026.
2. The original contract amount of \$567,374 is authorized to date. During the initial term of the contract, five amendments have increased the contract amount by \$311,607.86. Amendment 6 adds the funding needed to extend the contract for one year for a total of \$241,837. The new contract NTE is \$1,120,818.86 for Fire Systems Inspection and Maintenance services.
3. Schedule B replaces the previous compensation schedule in Section 3.a of the original agreement.

4. All other terms and conditions of the Contract shall remain unchanged.
