CALL TO ORDER

Council Chair Wright called the public hearing to order at 10:30 a.m.

ACTION ITEMS

Chair Wright opened the public hearing for all three ordinances, Nos. 21-029, 21-030, and 21-031. The clerk read the title for each ordinance into the record.

Ryan Countryman, Sr. Legislative Analyst, provided a brief staff report for each ordinance and summarized the proposed amendment for Ordinance 21-031. He responded to Councilmember Low regarding the fees for food trucks and confirmed that it would make the fee lower.

Chair Wright provided instructions for in-person and remote participation for those wishing to provide public testimony, she then opened the hearing for public testimony. There being no persons present wishing to testify, she closed the testimony portion of the hearing calling for a motion or discussion of the Council.

1. Ordinance 21-029, relating to the regulation of construction; [2021-0177](#)
adopting the 2018 edition of the International Mechanical Code as revised, the 2018 edition of the Washington State Energy Code as revised, the 2018 edition of the Uniform Plumbing Code as revised; and amending sections in chapters 30.51A, 30.52B, 30.52D and 30.52E SCC

ACTION: Vice-Chair Dunn made a motion to approve Ordinance No. 21-029. Councilmember Mead seconded the motion. The clerk called the roll and the motion to approve Ordinance No. 21-029 carried unanimously.

2. Ordinance 21-030, relating to the regulation of construction; [2021-0268](#)
adopting the 2018 edition of the International Building Code and International Residential Code, as revised; amending sections in chapters 30.50, 30.52A and 30.52F of the Snohomish County Code

ACTION: Vice-Chair Dunn made a motion to approve Ordinance No. 21-030. Councilmember Mead seconded the motion. The clerk called the roll and the motion to approve Ordinance No. 21-030 carried unanimously.

3. Ordinance 21-031, relating to the regulation of construction; [2021-0269](#)
adopting the 2018 edition of the International Fire Code as revised; adding and amending fees; and amending and adding sections in chapters 30.53A and 30.86 SCC
