CALL TO ORDER

ACTION ITEMS

Chair Wright opened the public hearing for all three ordinances, Nos. 21-029, 21-030, and 21-031. The clerk read the title for each ordinance into the record.

Ryan Countryman, Sr. Legislative Analyst, provided a brief staff report for each ordinance and summarized the proposed amendment for Ordinance 21-031. He responded to Councilmember Low regarding the fees for food trucks and confirmed that it would make the fee lower.

Chair Wright provided instructions for in-person and remote participation for those wishing to provide public testimony, she then opened the hearing for public testimony. There being no persons present wishing to testify, she closed the testimony portion of the hearing calling for a motion or discussion of the Council.
