

**AMENDMENT NO. 2 TO THE INTERLOCAL AGREEMENT
BETWEEN THE TOWN OF DARRINGTON
AND SNOHOMISH COUNTY CONCERNING PROVISION
OF FIRE INVESTIGATION SERVICES**

THIS AMENDMENT NO. 2 TO THE INTERLOCAL AGREEMENT BETWEEN THE TOWN OF DARRINGTON AND SNOHOMISH COUNTY CONCERNING PROVISION OF FIRE INVESTIGATION SERVICES (this "Amendment") is made and entered into as of this 13 day of May, 2026, by and between Snohomish County, a political subdivision of the State of Washington (the "County"), and the Town of Darrington, a Washington municipal corporation (the "Town").

RECITALS

- A. The County and the Town are parties to the "Interlocal Agreement Between the Town of Darrington and Snohomish County Concerning Provision of Fire Investigation Services" executed on June 3, 2021 (the "Original Agreement").
- B. Pursuant to Section 9 of the Original Agreement, the Director of the County's Department of Planning and Development Services and the Town Mayor each have authority to execute amendments to the Original Agreement to the extent and under the circumstances more fully described herein.
- C. The County and the Town executed Amendment No. 1 to the Original Agreement on July 24, 2023, which extended the Term of the Original Agreement through December 31, 2026, and adopted a new fee schedule for the extended term.
- D. The County and the Town now desire to amend the Original Agreement a second time to extend the Term of the Original Agreement through December 31, 2028, to allow the County to continue to provide Fire Investigation Services to the Town.
- E. The County and the Town further desire to amend the Original Agreement a second time to adopt a new fee schedule that provides annual rates for the term extended by this Amendment.

AGREEMENT

NOW, THEREFORE, in consideration of the respective agreements set forth below and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the County and the Town agree as follows:

Section 1. EXTENSION OF TERM

The County and the Town agree that the Term specified in Section 8 of the Original Agreement and previously extended through December 31, 2026, by Amendment No. 1 to the Original Agreement shall be extended by two (2) years. The new Expiration Date of the Agreement is December 31, 2028.

Section 2. ADOPTION OF NEW FEE SCHEDULE

The County and the Town agree to adopt a new fee schedule as provided herein:

Section 3. RATIFICATION

Except as modified by this Amendment or any prior amendments, the Original Agreement shall remain in force and effect in accordance with its terms and is hereby ratified and affirmed.

Section 4. EXECUTION IN COUNTERPARTS


This Amendment may be executed in counter parts, each of which shall be an original and all of which shall constitute one and the same instrument.
