To Jeremy Husby and the Snohomish County Arts Commission,

Hello board members. My name is Kari Johnson and I am an artist who lives and works from my home studio in Lake Stevens. As someone who is newer to this state and region, I do not have many connections to the area arts community, but as a former military spouse (my husband is now retired) I was given the opportunity to build robust communities of artists using online platforms. As a military spouse forced to move every 2-3 years to a new duty station (sometimes completely disconnected from the previous one) it's hard to maintain a sense of community with the place where you live. So many spouses, like myself, move to online platforms to display, connect, and gain support and encouragement.

It is my understanding of these communities and ability to connect with them that I believe would make me an asset to the committee. Many military families have a wealth of talents and stories to tell and their participation in this community, however brief, should be embraced and encouraged.

In my short time here I've been able to volunteer with my son's elementary school art docent program. It has been an absolute joy to share my knowledge of art and paint alongside them. I believe fostering and encouraging artist exploration and unencumbered creativity can help build on all aspects of education. I also believe access to local artists within their community and throughout the arts will help children think of their own creative futures, whether professionally or as a hobby.

I grew up in a small, rural community hundreds of miles from a major city. Our arts program consisted mostly of no 2 pencils and computer paper. And while there was a small thriving arts community in my hometown, it felt miles away from me. My children, our children should know that you don't need to be in the city center to have a thriving community and you don't need fancy tools to be a real artist.

I would like to use my platform an artist, mother and former military spouse to help bridge the gap between the work of the Arts Commission, the County and the community.
