PROPOSED ORDINANCE NO. 25-006

CORRECTING INADVERTENT ERRORS IN TITLE 13

SNOHOMISH COUNTY CODE (SCC), AMENDING SCC
13.110.010

Background: The ordinance corrects inadvertent errors and restore subsections (5) through (8) which had been previously codified before adoption of Ordinance 21-032 and make a minor nousekeeping amendment to add a period to the end of subsection (8). On July 21, 2021. the Snohomish County Council adopted Ordinance 21-032 relating to the requirements for utilities in county right-of-way and amending chapters 2.02, 13.10, 13.50, 13.60, 13.80 and 13.110 SCC. After the codification of the ordinance, the county identified in advertent errors in chapter 13.110 SCC consisting of the omission of subsections (5) through (8) of SCC (5) Repair and Replacement Charge, for actual costs associated with having to repair and/or replace any right-of-way or county facility not covered under any other fee.
(6) Footage Fee, this is a lineal footage fee as part of Type D5 and D8 permits.
(7) Road Cut Fee, for road shoulder or road asphalt/concrete cuts as part of the Type D8 permit.
(8) Private Right-of-Way Lease Fee, this is an annual fee charged at fair market value for leased county road right-of-Way. This is in addition to other fees.
