

AMENDMENT No. 1 TO 2023-2024 PSE HELP LOW INCOME PROGRAM AGENCY AGREEMENT

This Amendment No. 1 ("Amendment No. 1") to Low Income Program Agency Agreement No. 4600002925, effective as of last signature date below ("Amendment Effective Date"), is by and between **Puget Sound Energy, Inc.** ("PSE") and **Snohomish County Human Services** ("Agency" and together with PSE, "Parties").

A. PSE and Agency have entered into the Low Income Program Agency Agreement No. 4600002925, dated 10/1/2023, as amended or supplemented from time to time ("Agreement").
