### **Consideration**

Amendment No. 2 to the professional services agreement with AB Staffing Solutions for contract medical staffing within the Snohomish County Jail.

### **Background**

The Snohomish County Jail operates a 24/7 medical department in service to the inmate population and in accordance with [SCC 5.12](#) and [RCW 72.10](#). The Correction's bureau contracts for temporary medical staffing to provide services when needed to cover employee absences, vacancies, etc.

Motion 21-303<sup>1</sup>, approved on September 15, 2021, an agreement with AB Staffing Solutions for contract medical staffing to supplement services provided by Health Pros Northwest. The agreement included four types of specialty providers: Registered Nurse/Correctional; LPN/Correctional; LPC/LCSW and Social Worker/Non-Licensed with master's degree. The fee structure for services provided under each specialty was amended in 2022 through Amendment No. 1, [Motion 22-329](#).

### **Current Proposal**

*Scope:* Motion 23-275 approves Amendment No. 2 to the professional services agreement with AB Staffing Solutions for contract medical staffing. The amendment adjusts the fee structure only, there are no changes to the rest of the agreement. Below is a summary of the rates as amended over time, the proposed new rate, and the difference between the current rate under Amendment No. 1 and the proposed new rate under Amendment No. 2. Two of the rates decrease, one rate increases, and one has no change.

*Duration:* No change to the term - September 1, 2021-December 31, 2025. Renewals allowed for up to three (3) additional one (1) year terms. Termination for convenience is allowed upon 60 days advance written notice.

*Fiscal Implications:* None – there is no change to the do not exceed amount of \$3,437,500 for the term of the agreement.
