Subject: Law Enforcement Assisted Diversion Program – Amendment #1 - Evergreen Recovery Center

Authority Granted: Authorize the Executive to execute the contract.

Background: The Law Enforcement Assisted Diversion (LEAD) arrest diversion program is a collaborative community safety effort that offers law enforcement a credible alternative to booking people into jail for criminal activity that stems from unmet behavioral health needs or poverty.¹

Through the approval of Motion 20-121 in June of 2020, the Prosecuting Attorney's Office (PAO) implemented the Law Enforcement Assisted Diversion (LEAD) program, funded through grant dollars. The majority of the funding for this program is passed through to other agencies for service administration and delivery. Evergreen Recovery Center is one of these agencies. The County has been contracting with them for this purpose since 2020. On October 15, 2025 Council approved the most recent contract with Evergreen Recovery Center for these services (see below).
