6 APPROVING AND AUTHORIZING THE COUNTY EXECUTIVE TO SIGN AN
7 INTERLOCAL AGREEMENT BETWEEN SNOHOMISH COUNTY AND THE CITY OF
8 LYNNWOOD REGARDING SNOHOMISH COUNTY OUTREACH TEAM

10 WHEREAS, the City of Lynnwood (hereafter “City”) and Snohomish County (hereafter
11 “County”) have negotiated the terms of an Interlocal Agreement (hereafter “Interlocal
12 Agreement”) for the purpose of the County providing a pilot program that embeds a full time
13 County- employed social worker within Lynnwood and Mountlake Terrace police force
14 (hereafter “Services”); and

16 WHEREAS, the City of Lynnwood commits to providing \$105,401 of the cost to embed
17 a social worker in law enforcement from execution of the Interlocal Agreement and continuing
18 until December 2024; and

20 WHEREAS, the Interlocal Agreement outlines the duties of the respective parties and
21 identifies the objectives and strategies of the pilot program; and

23 WHEREAS, the County is agreeable to rendering such Services on the terms and
24 conditions contained in the Interlocal Agreement; and

26 WHEREAS, the Interlocal Agreement is authorized by and is consistent with the
27 requirements of the Interlocal Cooperation Act, Chapter 39.34 RCW; and

29 WHEREAS, the Snohomish County Council held a public hearing on _____,
30 2024, to consider approving the Interlocal Agreement and authorizing the Snohomish County
31 Executive to sign the Interlocal Agreement on behalf of the County.

33 NOW, THEREFORE, BE IT ORDAINED:

35 Section 1. The County Council hereby adopts the foregoing recitals as findings of fact
36 and conclusions as if set forth in full herein.

38 Section 2. The Snohomish County Council approves and authorizes the Snohomish
39 County Executive, or designee, to sign the Interlocal Agreement between Snohomish County and
40 the City of Lynnwood Regarding Snohomish County Outreach Team.
