MOTION NO. 22-512

AUTHORIZING THE COUNTY EXECUTIVE TO SIGN THE
2023-2025 ON-CALL CONSULTANT SERVICES MASTER AGREEMENTS
FOR THE CONSERVATION AND NATURAL RESOURCES DISCIPLINE

WHEREAS, the Department of Conservation and Natural Resources has determined the need for consultant services on an on-call as-needed basis for emergency projects, time critical projects, and for elements of projects where the required expertise and/or staffing is not available; and

WHEREAS, the current 2019-2022 On-Call Consultant Services program expires as of December 31, 2022; and

WHEREAS, the nineteen (19) highest ranking consultants responding to RFQ-22-006SB, under the Conservation and Natural Resources discipline, as shown in Exhibit A, were selected through established Federal, State and County policies and practices; and

WHEREAS, Council's approval of the 23-25 On-Call Consultant Services Master Agreements for Conservation and Natural Resources will allow the Department of Conservation and Natural Resources to meet County goals and to provide services to other County departments on an on-call basis;

NOW, THEREFORE, ON MOTION, the Snohomish County Council approves and authorizes the County Executive to sign the 2023-2025 On-Call Consultant Services Master Agreements for the Conservation and Natural Resources discipline with an umbrella amount not to exceed \$14,300,000.00, and further authorizes the Director of Conservation and Natural Resources or designee to approve Administrative Supplements and Task Assignments issued under the Master Agreements provided that sufficient appropriation authority exists.
