AMENDING 25.20.120 OF THE SNOHOMISH COUNTY CODE RELATING TO STORM AND SURFACE WATER MANAGEMENT

<u>Summary:</u> The ordinance amends Snohomish County Code 25.20.120 Delinquent Service Charges to allow a motion for cancellation of uncollectible surface water charges to be brought to Council at ay time during the course of lawful collections actions.
