## Consideration

The Executive's Office requests Council consider approving proposed Motion 21-350 which would approve and authorize a budget transfer between programs in Human Services.

## **Background**

Human Services received more funds for Housing, Homeless and Community Development from state and federal grants than was anticipated in the 2021 budget. Several actions have been taken to receive those funds and update associated agreements:

- CDBG-3 Grant approved under Executive Authority (<u>SCC 2.36.040(3)(b)</u>) to increase thea amount for housing and essential needs at risk and utility funding of \$3,500,000 and increased voucher funding from \$1,600,000 to \$2,200,000;
- ESD-CV Rent from HUD approved under Executive Authority (<u>SCC 2.36.040(3)(b)</u>) increasing emergency shelter funding from \$914,410 to \$5,696,945;
- Commerce Shelter Program approved via Motions 20-371<sup>1</sup> and 21-129<sup>2</sup> for \$4,339,548; and
- Commerce 2020-2021 Consolidated Housing Grant Amendment A included in the 2020 Grant Work Plan for \$1,970,274.3

To utilize the funds for planned activities in 2021, a budget transfer out of Pending Grants is needed.

## **Current Proposal**

*Scope:* Motion 21-350 approves a budget transfer between programs in Human Services of \$2,470,000 out of Pending Grants into the following DACs:
