Council Chair Wright opened the hearing and the clerk read the ordinance title into the record.

Jim Martin, Senior Legislative Analyst, provided a staff report and explained the proposed amendments.

Mary Jane Brell-Vujovic, Human Services Director, along with Ken Klein and Lacey Harper, Executive Directors, responded to questions from Councilmembers relating to the proposed use of funds. In response to questions regarding housing and homeless services, Ms. Brell-Vujovic explained that the County will coordinate with the affected jurisdictions on any proposed acquisition of properties.

Council Chair Wright noted that the proposed Amendment 4 has been withdrawn.

Councilmember Nehring explained proposed Amendment 5, which encompasses the intent of both Amendments 1 and 1A.

Council Chair Wright opened the hearing for public testimony and provided instructions for remote participation in the Zoom meeting.
