GRANTING A NONEXCLUSIVE CABLE FRANCHISE AUTHORIZING  
LIMITED USE OF THE PUBLIC ROAD RIGHTS-OF-WAY IN  
SNOHOMISH COUNTY, WASHINGTON TO ZIPLY FIBER  
NORTHWEST, LLC D/B/A ZIPLY FIBER

ZiPLY Fiber Northwest, LLC D/B/A ZiPLY Fiber has applied to Snohomish County, Washington, for a non-exclusive franchise to construct, maintain, operate, replace and repair a telecommunications network in, on, across, over, along, under, and/or through public rights-of-way within unincorporated Snohomish County.

If approved, proposed Ordinance No. 24-034 would grant said franchise to ZiPLY Fiber Northwest, LLC D/B/A ZiPLY Fiber, subject to all of the terms and conditions contained in the ordinance.

If approved, the franchise would go into effect following enactment of the ordinance, acceptance by ZiPLY Fiber Northwest, LLC D/B/A ZiPLY Fiber, provision of evidence of insurance, and payment of all applicable fees. The maximum term of the franchise would be five (5) years from the effective date.

At the Public Hearing, the Council may consider amendments to the proposed ordinance.

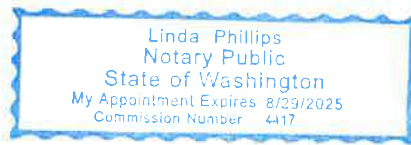


