

**AMENDMENT 3 TO THE SOFTWARE LICENSE AND SERVICES AGREEMENT
FOR PETTRACK SYSTEM SOFTWARE**

THIS AMENDMENT 3 TO THE SOFTWARE LICENSE AND SERVICES AGREEMENT FOR PETTRACK SYSTEM SOFTWARE (“Amendment 3”) is entered into as of this 29th day of June, 2023, by and between Snohomish County, a political subdivision of the State of Washington (the “County”), and Progressive Solutions, Inc., a California corporation (“PSI”, “Contractor”, or Licensor”).

RECITALS

WHEREAS, the County and Contractor are the parties to that certain “Software License and Services Agreement for PetTrack System Software” executed on January 11, 2013, and amended on January 21, 2016, and December 16, 2022 (the “Master Agreement”); and

WHEREAS, the County desires to continue to receive software maintenance for LicenseTrack and PetTrack; and

WHEREAS, the County and Contractor have agreed to extend the Master Agreement until January 10, 2029, with annual support and maintenance payment due on or before January 10 of each year; and

WHEREAS, the estimated total cost of this Amendment 3, through January 10, 2029, is One Hundred Twenty-Three Thousand Seven Hundred Twenty Dollars and Zero Cents (\$123,720.00) plus applicable sales tax.

NOW, THEREFORE, in consideration of the covenants hereinafter set forth and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the County and PSI agree as follows:

1. Part 6.A. - Term of Agreement, is hereby amended to read as follows:
 - A. **Term of Agreement.** The term of the Master Agreement shall commence upon execution and continue through January 10, 2029, with annual support and maintenance payments due on or before January 10 of each year. Extensions are subject to termination as provided in this Master Agreement.
2. A new article 9.A.2. is added to Part 9. Price and Payment as follows:
 - A.1. Beginning with year 12 and continuing through year 16, the annual Support and Maintenance Services fee will increase using the October 12 month, BLS Consumer Price Index (CPI) rate for the Los Angeles area or 3%, whichever is greater, plus applicable sales tax.

3. A new section is added to Exhibit A – Requirements Analysis Report, Appendix C: Cost Summary Sheet and Payment Schedule as follows:

4. All other terms of the Master Agreement shall remain in full force and effect, except as expressly modified in this Amendment 3.
