

**AMENDMENT 3 TO THE PROFESSIONAL SERVICES AGREEMENT BETWEEN
SNOHOMISH COUNTY AND JUDGE TECHNICAL SERVICES, INC.**

This Amendment 3 to the "Professional Services Agreement," (the "Master Agreement"), executed on December 24, 2018, as amended by Amendment 1 dated May 12, 2023, and Amendment 2 dated March 27, 2024 (together hereafter the "Agreement"), by and between Snohomish County, a political subdivision of the State of Washington (the "County") and Judge Technical Services, Inc. (the "Contractor") duly registered and authorized to conduct business in Washington State (the "Contractor") is made and entered into as of the last date set forth in the signature block below ("Effective Date").

RECITALS

WHEREAS, the County and Contractor entered into a Master Agreement for IT Staff Augmentation Services on December 24, 2018 as amended by Amendment 1 dated May 12, 2023, and Amendment 2 dated March 27, 2024; and

WHEREAS, the Contractor provides additional professional IT staffing as needed during times of peak workload or provides assistance in areas where IT lacks expertise or resources; and

WHEREAS, the initial term of the Agreement is five years from execution and allows up to five (5) one (1) year extensions; and

WHEREAS, the County by written notice extended the Agreement for the first three (3) additional one (1) year terms from December 24, 2023, through December 23, 2026; and

WHEREAS, the County wishes to extend the current Agreement for the two (2) remaining additional one (1) year terms beginning December 24, 2026, through December 23, 2028; and

WHEREAS, based on the County's expected usage, an increase of Six Hundred Thousand Dollars (\$600,000.00) to the maximum total contract is needed.

NOW, THEREFORE, for and consideration of the mutual benefits conferred on both parties, the parties agree as follows:

1. Part 2 Term of Agreement; Time of Performance of the Master Agreement is hereby amended to read as follows:
 2. Term of Agreement; Time of Performance. This Agreement shall be effective upon contract execution (the "Effective Date") and shall terminate on December 23, 2028, PROVIDED, HOWEVER, that the County's obligations after December 31, 2018, are contingent upon local legislative appropriation of necessary funds for this specific purpose in accordance with the County Charter and applicable law.
2. Part 3(f) Compensation; Contract Maximum of the Master Agreement, is hereby amended to read as follows:

f. Contract Maximum. Total charges under this Agreement, all fees and expenses included, shall not exceed \$2,220,000.00.
