6 APPROVING AND AUTHORIZING AN AMENDED AND RESTATED SNOHOMISH
7 COUNTY REGIONAL PUBLIC SAFETY COMMUNICATIONS AGENCY INTERLOCAL
8 AGREEMENT

10 WHEREAS, Snohomish County 911 provides emergency communication
11 services on behalf of its member agencies throughout Snohomish County; and

12
13 WHEREAS, Snohomish County is a Principal of Snohomish County 911; and

14
15 WHEREAS, the Snohomish County Regional Public Safety Communications
16 Agency Interlocal Agreement (the "Agreement") became effective as of January 1,
17 2018, to provide a governance structure to oversee the operations of emergency
18 communication services; and

19
20 WHEREAS, the Agreement provides that certain amendments to the Agreement
21 may be approved by the Snohomish County 911 Governing Board, except for
22 amendments related to those topics set forth in Section 18(a)-(g), which must be
23 approved by the legislative authorities of the Principals; and

24
25 WHEREAS, the Snohomish County 911 Governing Board has recommended
26 changes to the Agreement that require approval by the legislative authorities of the
27 Principals and has submitted the Amended and Restated Snohomish County Regional
28 Public Safety Communications Agency Interlocal Agreement (the "Amended and
29 Restated Agreement") for County approval; and

31 WHEREAS, the Amended and Restated Agreement changes the process of
32 dividing the Governing Board seats to more closely follow the assessment formula as
33 specified therein; and

35 WHEREAS, the Amended and Restated Agreement also removes the single
36 non-voting Governing Board seat; and

38 BE IT ORDAINED:

40 Section 1. Approval of the Amended and Restated Agreement. The Snohomish
41 County Council hereby approves the Amended and Restated Snohomish County
42 Regional Public Safety Communications Agency Interlocal Agreement in substantially
43 the form attached hereto as Exhibit A and incorporated herein by this reference.

1 Section 2. Subsequent Amendments. The Snohomish County Council further
2 authorizes that subsequent amendments requiring Council approval may be submitted
3 by the Executive to Council for approval via motion.
