**Element 9.0 Construction Support**

**9.1 Design Services During Construction**

The role of the CONSULTANT and its team under this task is to respond to the AGENCY to assist in the resolution of design issues related to contract documents and field conditions.

The 36<sup>th</sup>-35<sup>th</sup> Ave W Improvements project was originally contracted in 2008. During the initial stages of construction, the project has encountered a number of differing site conditions that weren't originally identified in the preliminary work (such as the potential of petroleum remnants in the soils). These conditions require additional consultation, field observations, testing, subconsultant coordination, testing results review, recommendations, meetings, and site visits.

The CONSULTANT shall support the AGENCY with these additional construction support activities.

**Activities:**

- Perform and respond to field visit requests from AGENCY in support of Requests For Information, Deviations, Substitutions, unknown or new site conditions, utility coordination, etc.
- Attend meetings (virtual or on-site) on an as-needed basis.
- Additional submittal and work plan reviews.
- Materials testing results reviews and conformance to original design.
- Perform field site visits, as requested by AGENCY.

**Deliverables:**

- Attendance at meetings and notes, as needed for each meeting.
- Site review notes.
- Recommendations as needed based on materials testing.
- Subconsultant field and office support.
