APPROVING THE APPORTIONMENT OF
2023 PUBLIC UTILITY DISTRICT PRIVILEGE TAXES

WHEREAS, Snohomish County has received the amount of \$7,783,446.43 from the State of Washington for Snohomish County Public Utility District No.1, privilege taxes; and

WHEREAS, RCW 54.28.090 authorizes the County Council to stipulate the distribution of said funds subject to certain limitations; and

WHEREAS, the County Council has determined that these funds should be distributed as set forth below;

NOW, THEREFORE ON MOTION, Snohomish County Council hereby authorizes and directs the Snohomish County Treasurer to distribute \$3,037,259.46, representing 3/4 of 1% of revenue derived from the cities and towns to the cities and towns in accordance with the schedule below, and to deposit the balance, \$4,746,186.97 into the General Fund.
