SNOHOMISH COUNTY, WASHINGTON TO FATBEAM, LLC

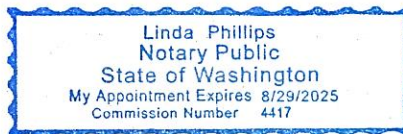
