**Subject:** Change Order No. 5 to bid PW-24-028SB, New Start Center (NSC) of Edmonds.

**Scope:** Change order No. 5 is for the replacement of the existing Fire Alarm System. This includes from conduit, wire, devices, submittals, shop drawings and permits for a completely new fire alarm system. This would bring the Fire Alarm system into compliance with RFI 16. This does not include any drywall removal or patching, as the extent is unknown at this time.

The 2024 Housing and Behavior Health Capital Fund Investment Plan ([Motion 24-417](#)) requires County-owned property, capital contracts and subsequent amendments where the aggregate total of the contract and amendments total more than \$150,000 shall come to Council for approval by motion. Contracts below this amount may be approved by the Executive or designee.

**Background:** Snohomish County purchased the America's Best Value Inn (Edmonds) in August 2022, for a total purchase price of \$8,404,807.67; this includes closing costs and \$689,400 discount for abatement.
