PROPOSED ORDINANCE NO. 23-073

APPROVING THE INTERAGENCY AGREEMENT WITH DEPARTMENT OF ECOLOGY FOR THE POLLUTION PREVENTION ASSISTANCE PROGRAM

**Summary:** The ordinance approves an agreement for the Pollution Prevention Assistance Program (PPA) to provide funds for PPA Specialists who provide technical assistance to help businesses find and resolve potential pollution issues. The duration of the agreement is from July 1, 2023 to June 30, 2025.
