MOTION NO. 21-283

APPROVE AND AUTHORIZING THE SNOHOMISH COUNTY EXECUTIVE
TO EXECUTE AMENDMENT 3 OF THE
NORTH SOUND BH-ASO-SNOHOMISH COUNTY ICCN 20-21 CONTRACT

WHEREAS, SCC2.400.030 authorizes the Human Services Department to administer and coordinate County programs and projects relating to human services in accordance with County, State, and Federal laws and regulations; and

WHEREAS, Snohomish County provides crisis and coordination services to Snohomish County residents; and

WHEREAS, the North Sound Behavioral Health Administrative Services Organization (North Sound BH-ASO) provided funding for the Integrated Community Crisis Network (ICCN) in the amount of \$2,315,943.48 for the period 1/1/2020 through 6/30/2020; and

WHEREAS, North Sound BH-ASO ICCN Amendment #1 provided additional funding in the amount of \$2,513,225.48 through 12/31/2020; and

WHEREAS, North Sound BH-ASO ICCN Amendment #2 provided additional funding in the amount of \$2,513,225.48 through 6/31/2021; and

WHEREAS, Council approval of a grant work plan pursuant to SCC 4.26.025 shall provide authority for the Executive to approve and execute grant documents to implement the approved grant work plan in accordance with SCC 2.10.010(28). Such Council approval shall also provide authority for the Executive to approve and execute grant contracts for grants received in amounts up to \$50,000 greater than the amounts stated in the approved grant work plan; and

WHEREAS, the contract North Sound BH-ASO-Snohomish County ICCN 20-21 and amendment #1 were included in the 2020 Human Services Grant Work Plan, approved via motion 19-315; and


WHEREAS, contract Amendment #2 was included in the 2021 Human Services Grant Work Plan, approved via motion 20-411; and

WHEREAS, this contract Amendment #3 in the amount of \$2,513,228.48 for the period 7/1/2021 through 12/31/2021 now causes the contract total to exceed by more than \$50,000 the amount included in the 2021 Human Services Grant Work Plan;

NOW, THEREFORE, ON MOTION, pursuant to SCC 4.26.025, the Snohomish County Council approves and authorizes the Snohomish County Executive to execute North Sound Behavioral Health Administrative Services Organization Integrated Crisis Care Network Agreement, #North Sound BH-ASO-Snohomish County-ICCN-20-21 Amendment 3, for the period of 7/1/2021 through 12/31/2021, in the amount of \$2,513,228.48, and any subsequent amendments thereto.
