AMENDMENT NO. 1 TO THE INTERLOCAL AGREEMENT BETWEEN SNOHOMISH COUNTY, THE CITY OF LAKE STEVENS, AND THE LAKE STEVENS SEWER DISTRICT FOR THE SOUTHEAST INTERLOCAL ANNEXATION

THIS AMENDMENT NO. 1 TO THE INTERLOCAL AGREEMENT BETWEEN
SNOHOMISH COUNTY, THE CITY OF LAKE STEVENS, AND THE LAKE STEVENS
SEWER DISTRICT FOR THE SOUTHEAST INTERLOCAL ANNEXATION (this
"Amendment") is made and entered into as of this day of, 2021, by and
between Snohomish County, a political subdivision of the State of Washington (the
"County"), the City of Lake Stevens, a Washington municipal corporation (the "City"),
and the Lake Stevens Sewer District ("District"), a special purpose district of the State of
Washington, collectively referred to as the "Parties."

RECITALS

- A. The County, City, and District are parties to the "Interlocal Agreement Between Snohomish County, the City of Lake Stevens, and the Lake Stevens Sewer District for the Southeast Interlocal Annexation" executed on May 12, 2021 (the "ILA").
- B. The Parties now desire to amend the ILA to revise the annexation effective date, to replace the legal descriptions of Exhibit B of the ILA with revised legal descriptions, and to add a surveyor's map of the annexation area to Exhibit B of the ILA.

AGREEMENT

NOW, THEREFORE, in consideration of the respective agreements set forth below and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree to amend the ILA as provided herein.

Section 1. AMENDMENTS TO THE ILA. The Parties agree to amend the following section and exhibit of the ILA as set forth below:

- **3.5 Effective date of annexation**. The Parties agree that the City's annexation shall become effective July 16, 2021 <u>fifteen days after the action is deemed approved under</u> RCW 36.93.100(4).
- **Exhibit B.** The legal descriptions attached to the ILA are replaced and superseded with the revised legal descriptions attached hereto as "Revised Exhibit B." A surveyor's map of the annexation area is added and included with "Revised Exhibit B."

Section 2. RATIFICATION

Except as modified by this Amendment, the ILA shall remain in force and effect in accordance with its terms and is hereby ratified and affirmed.

Section 3. EXECUTION IN COUNTERPARTS

This Amendment may be executed in counter parts, each of which shall be an original and all of which shall constitute one and the same instrument.
