WHEREAS, in 1984 and in 1994, Presidents Ronald Reagan and Bill Clinton, respectively, signed a proclamation officially declaring Municipal Clerks Week the first full week of May and recognizing the essential role Municipal Clerks play in local government; and

WHEREAS, Professional Municipal Clerks provide a professional link among citizens, local governing bodies and agencies of government at all levels; and

WHEREAS, Professional Municipal Clerks have pledged to be ever mindful of their neutrality and impartiality, rendering equal service to all; and

WHEREAS, Professional Municipal Clerks serve as the information center on functions of local government, and willingly share their knowledge and expertise with those seeking to conduct business with government entities; and

WHEREAS, Snohomish County Council Professional Municipal Clerks have gone through extensive training to achieve their clerk certifications. They continually strive to improve the administration of their duties and responsibilities through participation in education programs, seminars, workshops and meetings of their state and local professional organizations; and

WHEREAS, it is appropriate that we recognize the accomplishments of the professionals who so capably serve Snohomish County; and

WHEREAS, initiated in 1969 by the International Institute of Municipal Clerks (IIMC) and endorsed by all of its members throughout the United States, Canada, and 15 other countries, Professional Municipal Clerks Week will celebrate its 53rd anniversary, this May;

NOW, THEREFORE, BE IT RESOLVED, that the Snohomish County Council recognizes the week of May 1 through May 7, 2022, as Professional Municipal Clerks Week, and further extends appreciation to our Professional Municipal Clerks, Debbie Eco and Elena Lao and to all Professional Municipal Clerks for the vital services they perform and their exemplary dedication to the communities they serve.
