

## First Addendum to Web Hosted Database Software Service and Support Agreement

The Parties herein wish to add to the terms of scope of services through this first addendum dated June 11, 2018 ("Addendum") to the **Web Hosted Database Software - SERVICE AND SUPPORT AGREEMENT** entered into on September 1, 2015 between ProDIGIQ, Inc. (hereafter "ProDIGIQ") and the County of Snohomish, Washington, a Washington municipal corporation, of 3220 100<sup>th</sup> St SW., Everett, Washington 98204, which owns and operates the Paine Field Airport (hereinafter referred to as "PAE" or "Airport"), ("Agreement").

WHEREAS, Parties wish to extend the Scope of the Agreement to include the Operations Log Module;

NOW THEREFORE, in consideration of the mutual promises and consideration set forth herein, the receipt and sufficiency of which are hereby acknowledged, the Parties agree to amend the Agreement as follows:

1.01, ADDITIONAL DESCRIPTION OF SCOPE OF SERVICES: Paragraph 1.01 of the Agreement is amended to add the following scope of services: ProDIGIQ will provide the Operations Log Module to include; NOTAM integration, Part 139, Incident/Accident, FOD and Storm Water Module integration. Scope will include 40 hours of customization to implement Airport suggestions, tasks, etc. Additional customizations will be at a discounted rate of \$115 per hour. This amendment will include the Functional/Technical requirements that are agreed upon in the original contract in Exhibit A.

**PRICING:** Parties herein agree to pricing for the extended scope of the Agreement to include Implementation Cost and Ongoing service:

Except as expressly amended in this Amendment, all terms and conditions of the Agreement shall remain unchanged and will continue in full force and effect to the extent permitted under the Agreement. In the event of any conflict between the terms set forth in this Amendment and the terms set forth in the Agreement, the

terms of this Amendment shall govern. All capitalized terms herein shall be given the meaning afforded to them in the Agreement.
