Dear Mr. Moilanen,

As you know the County and District executed an interlocal agreement dated January 14, 2022. Since that time there have been three amendments related to additional but related services executed on May 29, 2024, September 23, 2024 and October 9, 2024.

The Interlocal agreement provides, in Section 5.5 for "Extra Work" through a binding Letter of Agreement in the form of an Amendment.

The Project has encountered costs that were not anticipated as specific bid items in the previous Exhibit B. This letter adds the following items as shown below.
