17 Section 1. The County Council makes the following findings of fact: A  
18 supplemental appropriation is necessary in General Fund 002, in the 2025-2026 budget,  
19 in the amount of \$447,697.02, to provide expenditure authority for funds received from  
20 the Washington State Office of Public Defense for the purpose of making improvements  
21 to indigent defense.
