J. Other Business

1. Economic Alliance Snohomish County (EASC) Economic 2022-0630

Development Update - Garry Clark, CEO

James Henderson, Chief Economic and Workforce Development, Executive's Office, provided introductory remarks relating to the EASC update.

Garry Clark, EASC President and Chief Executive Officer, presented a comprehensive update on EASC's growth development strategy as a catalyst for

economic vitality. He provided an overview of the six pillars of economic development: advocacy; business attraction; business retention and expansion; quality of life; small business and chamber; and workforce.

Discussion ensued as Mr. Clark and Mr. Henderson responded to questions from Councilmembers regarding support for new businesses, infrastructure improvements, tax and business incentives, permitting process, advocacy initiatives, concerns of businesses leaving Snohomish County, enhanced quality of life to support recruitment and retention, and revenue plans.

Councilmembers thanked the EASC, Mr. Clark, and Mr. Henderson for their efforts in strengthening economic development in Snohomish County.

Snohomish County Sheriff's Office Crime Statistics – Sheriff Adam 2022-0670
 Fortney

Snohomish County Sheriff Adam Fortney addressed the Council and explained the decision to discontinue the publication of the Sheriff's Office Annual Report. He explained that In 2019, in lieu of a publication, the Sheriff's Office released a video review of an annual report that has reached larger audiences than a printed report. He noted that the Sheriff's Office is working with the Department of Information Technology in launching an online dashboard, which is widely used by the law enforcement industry, for the public to extract and view crime statistics. Sheriff Fortney further explained that data from 2016 need to be updated for accuracy before the dashboard goes live for the public.

Councilmember Nehring indicated that the video review has been helpful and requested that the videos also be available on the proposed dashboard.

Council Chair Dunn thanked Sheriff Fortney for the Office of Professional Accountability reports and also requested that the information be available online.

Councilmember Low inquired about vacancies in the Sheriff's Office. Sheriff Fortney explained the current vacancy status and the challenges of recruitment and retention.

Councilmembers thanked Sheriff Fortney for his report.
