

## Snohomish County Noxious Weed Board Districts

### **District 1**

Northern boundary is the Skagit County line. The southern boundary is approximately 7 miles south of the Skagit County line north of the southern border of Sections 1 - 6, Township 31N, running in an east west direction across the County.

### **District 2**

Northern boundary is south of the north line of Sections 7 - 12, Township 31N, running in an east and west direction across the County. The southern boundary is the southern boundary of section 7 - 12; Township 30N running in an east west direction. The area is south of 220<sup>th</sup> St NE Street and north of 108<sup>th</sup> St. NE. Much of Arlington is in this district.

### **District 3**

Northern boundary is south of 108<sup>th</sup> St. NE which is south of all Sections 7 - 12, Township 30N running in an east west direction. The southern boundary is North of 20<sup>th</sup> St. SE which is north of all Sections 25 - 30, Township 29N, running in an east and west direction. The southern boundary is north of Cavaleros Corner.

### **District 4**

Northern boundary is south of 30<sup>th</sup> St. SE or south of the north border of Sections 25-30, Township 29N running in an east west direction across the county. The southern boundary is north of 132<sup>nd</sup> Street and north of the northern boundary of Sections 31 - 36, Township 28N running in an east west direction. The city of Snohomish is located about in the middle of this district.

### **District 5**

Northern Boundary is the northern line of Sections 31 - 36, Township 28N. running east and west across the County. The district is south of 132<sup>nd</sup> Street. The southern boundary is the King County line.

### **3.42.090 Noxious Weed Control Districts**

#### **District 1**

Beginning where the south line of Section 3, Township 31 north, Range 3 east Willamette Meridian intersects with the westerly Snohomish county boundary, said point to be the T.P.O.B.; thence east along said south line of Section 3, to the easterly boundary of Snohomish county; thence northerly along said easterly boundary to the northerly boundary of Snohomish county; thence west along said northerly boundary to the westerly boundary of Snohomish county; thence south to the T.P.O.B.

#### **District 2**

Beginning where the south line of Section 3, Township 31 north, Range 3 east Willamette Meridian intersects with the westerly Snohomish County boundary, said point to be the T.P.O.B.; thence east along said south line to the Easterly boundary of Snohomish County; thence south along said easterly boundary to the south line of Section 10, Township 30 north, Range 15 east Willamette Meridian; thence west along said south line of Section 10 to the westerly boundary of Snohomish County; thence north along said westerly boundary to the T.P.O.B.

#### **District 3**

Beginning at the intersection of the south line of Section 10, Township 30 north, Range 15 east Willamette Meridian and the Easterly boundary of Snohomish County, said point to be the T.P.O.B. ; thence west along said south line of Section 10 to the westerly boundary of Snohomish County; thence south along said westerly boundary to the south line of Section 5, Township 29 north, Range 3 east Willamette Meridian; thence east along said south line of Section 5 to the Easterly boundary of Snohomish County; thence north along said easterly boundary to the T.P.O.B.

#### **District 4**

Beginning at the intersection of the north line of Section 36, Township 28 north, Range 3 east Willamette Meridian and the westerly boundary of Snohomish County, said point to be the T.P.O.B. ; thence east along said north line of Section 36 to the easterly boundary of Snohomish County; thence north to the north line of Section 30, Township 29 north, Range 14 east Willamette Meridian; thence west along said north line to the westerly boundary of Snohomish County; thence south along said westerly boundary to the T.P.O.B.

#### **District 5**

Beginning at the intersection of the north line of Section 36, Township 28 north, Range 3 east Willamette Meridian and the westerly boundary of Snohomish County, said point to be the T.P.O.B. ; thence east alongside the north line of Section 36 to the easterly boundary of Snohomish County; thence west to the westerly boundary of Snohomish County; thence north along said westerly boundary to the T.P.O.B.
