

**AMENDMENT NO.2 TO INTERLOCAL AGREEMENT
BETWEEN THE TOWN OF DARRINGTON AND
SNOHOMISH COUNTY CONCERNING
BUILDING/CONSTRUCTION/FIRE PLAN REVIEW AND
CODE INSPECTION SERVICES**

THIS AMENDMENT NO. 2 TO INTERLOCAL AGREEMENT BETWEEN THE TOWN OF DARRINGTON AND SNOHOMISH COUNTY CONCERNING BUILDING/CONSTRUCTION/FIRE PLAN REVIEW AND CODE INSPECTION SERVICES (this "Amendment") is made and entered into as of this 13 day of MAY, 2026, by and between Snohomish County, a political subdivision of the State of Washington (the "County"), and the Town of Darrington, a Washington municipal corporation (the "Town").

RECITALS

- A. The County and Town are parties to the "Interlocal Agreement between the Town of Darrington and Snohomish County Concerning Provision of Building/Construction/Fire Plan Review and Code Inspection Services" executed on June 3, 2021 (the "Original Agreement").
- B. Pursuant to Section 9 of the Original Agreement, the Director of the County's Department of Planning and Development Services has authority to execute an amendment to the Original Agreement to the extent and under the circumstances more fully described herein.
- C. The County and Town executed Amendment No.1 to the Original Agreement on July 24, 2023, which extended the term of the Original Agreement through December 31, 2026, and adopted a new fee schedule for the extended term.
- D. The County and Town now desire to amend the Original Agreement a second time to extend the term of the Original Agreement through December 31, 2028, to allow the County to continue to provide Building/Construction/Fire Plan Review and Code Inspection Services to the Town.
- E. The County and Town further desire to amend the Original Agreement a second time to adopt a new fee schedule that provides annual rates for 2027 and 2028, the term extended by this Amendment.

AGREEMENT

NOW, THEREFORE, in consideration of the respective agreements set forth below and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Town and the County agree as follows:

Section 1. EXTENSION OF TERM

The County and Town agree that the term specified in Section 8 of the Original Agreement and previously extended through December 31, 2026, by Amendment No. 1 to the Original Agreement shall be extended by two years. The new Expiration Date of the Agreement is December 31, 2028.

Section 2. ADOPTION OF NEW FEE SCHEDULE

The County and Town agree to adopt a new fee schedule as provided herein. The fee schedule set forth in this Amendment shall apply beginning January 1, 2027, and shall remain in effect for the duration of the extended term unless otherwise amended by the parties.
