VETERANS ASSISTANCE FUND EXECUTIVE BOARD DECEMBER 2024

SCC 2.40.030 authorizes the Human Services Department to administer and coordinate county programs and projects relating to human services in accordance with county, state and federal laws or regulations. Members of the board shall be honorably discharged veterans and be a member of a nationally recognized veterans' service organization or the veterans' community at large. Board members are recommended by the County Executive and confirmed by the County Council pursuant to Chapter 2.03 of the Snohomish County Code.
