6 RELATING TO THE 2021 BUDGET; MAKING A SUPPLEMENTAL APPROPRIATION IN
7 GRANT CONTROL FUND 130 TO PROVIDE EXPENDITURE AUTHORITY FOR
8 AMERICAN RESCUE PLAN ACT FUNDS

10 WHEREAS, on January 21, 2020, the Washington State Department of Health confirmed
11 the first reported case of the novel coronavirus (COVID-19) in the United States in Snohomish
12 County, Washington. COVID-19, a respiratory disease that can result in serious illness or death,
13 is caused by the SARS-CoV-2 virus, which is a new strain of coronavirus that had not been
14 previously identified in humans and can easily spread from person to person;
15

16 WHEREAS, since January 21, 2020, the disease has spread throughout the United States.
17 On January 31, 2020, the United States Department of Health and Human Services secretary Alex
18 Azar declared a public health emergency for COVID-19, beginning January 27, 2020. On
19 February 29, 2020, Washington State Governor Jay Inslee proclaimed a public health emergency
20 for COVID-19. On March 4, 2020, the Snohomish County Health Officer proclaimed a
21 countywide public health emergency for COVID-19. On March 4, 2020, Executive Dave Somers
22 issued a “Local Proclamation of Emergency Snohomish County” for COVID-19 (the
23 “Emergency”). On March 13, 2020, the President of the United States of America declared
24 COVID-19 a National Emergency;

26 WHEREAS, on March 10, 2021, the United States Congress passed the American Rescue
27 Plan Act of 2021 (“ARPA”),

29 WHEREAS, Section 9901 of ARPA created a Coronavirus State Fiscal Recovery Fund and
30 a Coronavirus Local Fiscal Recovery Fund; and

32 WHEREAS, the United States Department of Treasury provided direct relief to units of
33 local government through the Coronavirus Local Fiscal Recovery Funds (“CLFR”); and

35 WHEREAS, Snohomish County has received CLFR funds from the United States
36 Department of Treasury.

40 NOW, THEREFORE, BE IT ORDAINED:

42 **Section 1.** The County Council makes the following findings of fact: a supplemental
43 appropriation in the amount of \$76,702,064 is necessary in the Grant Control Fund 130 for budget
44 year 2021 to provide expenditure authority for direct aid provided to Snohomish County from the
45 United States Department of Treasury pursuant to Section 9901 of ARPA.
