***A RESOLUTION OF THE SNOHOMISH COUNTY COUNCIL HONORING THE STAFF

WHEREAS, Snohomish County is committed to fostering a compassionate and supportive community, ensuring that all residents have access to essential services, particularly during times of extreme weather conditions; and

WHEREAS, cold weather shelters in Snohomish County provide a vital service to those experiencing homelessness by offering a safe and warm refuge during the coldest months of the year; and

WHEREAS, the shelters rely on the selfless dedication and tireless efforts of its staff and volunteers who embody the spirit of community and public service, who generously give their time, energy, and resources to serve those in need; and

WHEREAS, these volunteers and staff coordinate shelter operations, provide meals, offer comfort and support, and ensure a welcoming and secure environment for individuals and families facing hardship which strengthens the fabric of our community, inspiring others to engage in service and outreach; and

WHEREAS, the cold weather shelters were open 34 out of 35 nights during the cold stretch lasting from January 11 through February 14, 2025; and




