Snohomish County Public Works has reviewed the above subject Plans. We have no comments, therefore I am pleased to approve the Plans per RCW 57.16.010.

The subject Plans are long-range development plans that do not provide project-specific information. As a result, I would like to emphasize the need to work with Snohomish County Public Works and/or Planning and Development Services whenever the District initiates design and construction of a particular improvement. Prior to any construction activities, required permits shall be obtained from applicable regulatory agencies. When development will occur within or adjacent to a County right-of-way, please contact Snohomish County Public Works' Special Projects Coordinator Brook Chesterfield at 425-261-9849.

In addition, please provide a copy of the District's annual facilities improvement plan and program to Mr. Chesterfield. These steps will facilitate the timely coordination of construction activities where road and water (or wastewater) system improvements are planned in the same time frame for a particular road corridor. You are also required to submit this to the Snohomish County Health Department and to the Snohomish County Council. Contact Debbie Eco (Clerk of the Council) at 425-388-7038.


The County Council is charged with reviewing the Water and Sewer System Plans under the criteria in RCW 57.02.040(3)(a), (b), and (c). The County Council shall decide within sixty days of a hearing whether to approve or not approve the proposed action.

The Cross Valley Water District (the District) Water System Plan (WSP), originally received on March 29, 2022, and resubmitted on March 15, 2023, has been reviewed, and in accordance with the provisions of WAC 246-290-100, is **APPROVED**.

Approval of the plan is valid as it relates to current standards outlined in Chapter 246-290 WAC, revised January 2022, Chapter 246-293 WAC, revised September 1997, Chapter 70.116 RCW, and is subject to the qualifications herein.

### **APPROVED NUMBER OF CONNECTIONS**

The analysis provided in the WSP supports that the water systems can support an “**unspecified**” designation for their approved number of connections. A specific number of approved connections will not be applied at this time. Development may occur in compliance with the schedule and information provided in this WSP. This designation may be rescinded (and replaced with a specified number of approved connections) if ODW determines that the WSP is no longer representative of system activities.

An approved update of this plan is required on or before May 1, 2033, unless ODW requests an update or plan amendment pursuant to WAC 246-290-100(9).

### **LOCAL GOVERNMENT CONSISTENCY**

This document meets local government consistency requirements for WSP approval pursuant to RCW 90.03.386 and RCW 43.20.

### **SERVICE AREA AND DUTY TO SERVE**

Pursuant to RCW 90.03.386(2), the service areas identified in this WSP service area map may now represent an expanded “place of use” for this system’s water rights. Changes in service area should be made through a WSP amendment.

The District has a duty to provide new water service within its identified retail service areas. This WSP includes service policies to describe how your system plans to provide new service within your retail service area.

## CONSTRUCTION WAIVERS

*Standard Construction Specifications* were approved. Consistent with WAC 246-290-125 (2), the water system may proceed with the installation of distribution main extensions ***provided the water system completes and keeps on file, the enclosed construction completion report form*** in accordance with WAC 246-290-125 (2) and WAC 246-290-120 (5) and makes them available for review upon request by the department.

## WATER RESOURCES

Below is the general regulatory language that applies to all water system approvals:


The department's review of your water system plan will not confer or guarantee any right to a specific quantity of water. The approved number of service connections is based on your representation of available water quantity. If the Washington Department of Ecology, a local planning agency, or other authority responsible for determining water rights and water system adequacy determines that you have use of less water than you represented, the number of approved connections may be reduced commensurate with the actual amount of water and your legal right to use it.

Dear Mike Johnson:

PACE Engineers on behalf of the Cross Valley Water District (District) submitted the 2022 Sewer System Plan Update in electronic format to the Department of Ecology (Ecology) for final review and approval on November 3, 2022.

In accordance with the Revised Code of Washington (RCW) 90.48.110 and Chapter 173-240 Washington Administrative Code (WAC), Ecology APPROVES the above-referenced document as a general sewer plan. A copy of the approved title page is enclosed for your records. Ecology's review and approval is limited to assuring compliance with the State water quality laws and regulations listed above. Nothing in this approval shall be construed as satisfying other applicable federal, state or local statutes, ordinances or regulations.

Sewage facilities within the planning area boundary must be constructed according to the approved General Sewer Plan or amendments thereto. Ecology notes that this general sewer plan included standard design criteria for collection system facilities. Therefore, engineering reports and plans and specifications for sewer lines extensions, including pump stations, need not be submitted for approval, except in the following situations. Ecology approval is necessary for sewer line extensions prior to construction when:

- The proposed sewers or pump stations involve installation of overflows or bypasses.
- The proposed sewers or pump stations discharge to an overloaded treatment, collection, or disposal facility.
