A. Call to Order

Outgoing Council Chair Wright called the meeting to order at 10:31 a.m. and provided instructions for those wishing to provide comment remotely via Zoom.

B. Roll Call

The clerk called the roll and stated that all five members were present.

C. Special Reports

1. Election of Council Chair and Vice-Chair for the year 2022

Outgoing Chair Wright opened the floor for nominations and nominated current Council Vice-Chair as Chair of the Council. There being no further nominations, outgoing Chair Wright closed nominations and provided supportive comments for current Vice-Chair Dunn.

Councilmember Nehring thanked outgoing Chair Wright for her leadership. He noted that he appreciated the Council's ability to work together beyond party lines, he said it is important to him that it is reflected in Council leadership. He asked current Vice-Chair Dunn if she is open to a future republican being included in the Council leadership rotation. Current Vice-Chair Dunn responded and explained that she supports a republican in leadership and rotation. She has seen good examples and has supported it in the past.

Councilmembers Low, Dunn, and Mead expressed their appreciation for outgoing Chair Wright's leadership, responsiveness, and mentorship. Councilmember Mead also expressed support for current Vice-Chair Dunn's nomination.

ACTION: The question was called for and the nomination for current Vice-Chair Dunn to serve as the 2022 Council Chair carried four to one with Councilmember Low voting against.

Council Chair Dunn presided over the meeting and opened the floor for nominations for Vice-Chair. Councilmember Wright nominated Councilmember Mead. There being no further nominations, Chair Dunn closed nominations and turned to Council for discussion.

Councilmember Wright provided supportive comments for Councilmember Mead.

Councilmember Nehring asked the same question regarding future rotation and working beyond party lines. Councilmember Mead responded and explained he has no problems working together and finds it healthy and productive.

Chair Dunn provided supportive comments for Councilmember Mead.

ACTION. The question was called for and the nomination for Councilmember Mead to serve as the 2022 Council Vice-Chair carried unanimously.

2. State Legislative Update - Gordon Thomas Honeywell

Lacey Harper, Executive's Office, provided an update on the joint letter with the Volunteers of America and Immigration Services NW requesting funding to support Afghan resettlement efforts in Snohomish County. She said she would like to know who will be participating from Council at this Friday's meeting.

Ms. Harper said they have a meeting scheduled with Senator Marko Liias to talk about transportation needs and requested a councilmember to attend that meeting.

Josh Weiss, Gordon Thomas Honeywell, provided an update on this week's Legislative Session and upcoming hearings. He spoke about the following items:

- 1. Regional Apprentice Pathways Program (RAP)
- 2. Senate Bill 5575 Addition of two superior court judges
- 3. House Bill 1726 and House Bill 1735 Police Reform
- 4. House Bill 1732 and House Bill 1733 Update on changes to Long Term Care Act
- 5. House Bill 1722 and Senate Bill 5775 Microtrenching,
- 6. Senate Bill 5514 Meetings outside of the county seat

Mr. Weiss responded to questions from Councilmembers Low and Dunn related to timing of public notice. Mr. Weiss will look into a possible opportunity for shorter public notice time.

7. Senate Bill 5528 - Allow Sound Transit to designate enhanced service zones

Ms. Harper added that she has been in contact with Sound Transit and said there will be a briefing today with Snohomish County representatives of the Board and would like to circle back on this matter next week.

- 8. Senate Bill 5597 Expanding WA Voting Rights Act
- 9. House Bill 1663 Regulation and reporting from landfills, active or closed, on methane emissions
- 10. House Bill 1616 prohibits weapons at elections offices
- 11. House Bill 1643 related to exempting property transfers for affordable housing

Councilmember Nehring explained he is working on a resolution related to Long Term Care payroll tax requesting that the legislature adopt an extension of the opt out period along with the delay of implementation. He said he would like to have a conversation and put on the floor for today or General Legislative Session on Wednesday.

Responding to Councilmember Low, Mr. Weiss said they are having two hearings related to the Long Term Care Act this week. Councilmember Nehring

explained that his concern is for the opt out period. Discussion ensued regarding the concern about the extension for the opt out period. Councilmember Nehring suggested to move forward with his resolution on Wednesday and if Mr. Weiss gets information that the Long Term Care Act Bill addresses the extension of the opt out period, the resolution can be pulled.

[Councilmember Wright left the meeting at 10:58 a.m.]

Councilmember Low explained people registered to vote out of state should be exempted from this tax. Councilmembers Mead and Nehring agreed.

Ms. Harper said she will confirm with the Council Chief of Staff for participation on the meetings related to the funding for Afghan resettlement efforts and the transportation meeting with Senator Liias.

3. Resolution 22-001, recognizing January 9, 2022, as National Law Enforcement Appreciation Day

ACTION: Vice-Chair Mead made a motion to approve Resolution 22-001. Councilmember Low seconded the motion and it carried unanimously by the four members present.
