**Background:** Long-term tenants of the Snohomish County Airport and other outside entities may have caused or contributed to hazardous waste, substances, pollutants, and contaminants on Airport property in various locations. By previous motions, the County Council authorized the County Executive to sign a legal professional services agreement with HCMP to receive specialized consultation and advice regarding the Airport in various locations.

**<u>Request:</u>** Move to General Legislative Session on September 13, 2023, for consideration.

<sup>&</sup>lt;sup>1</sup> The original contract for \$25,000 was with Joyce Ziker Partners PLLC (JZP) and did not require Council authorization. Amendment 1 revised the names of the attorneys (the attorneys of JZP joined HCMP and are still providing services to Snohomish County under the agreement). Amendment No. 2 (Motion 20-254) added \$125,000 compensation. Amendment No. 3 (Motion 22-396) added \$30,000 compensation. Amendment No. 4 (Motion 23-088) again revised the names of the attorneys.
