Oil Filters (per pound)	\$ 1.00	.50 to 1 - 97% disposal price increase
Oil Filters (55 gallon drum)	\$ 83.00	SW pays \$69/55 Gal for disposal - added 20% to cover, supplies and staff time associated with scheduling, receiving and processing the material
Oils Various (per pound)	\$ 0.40	.25 to .40 - 53% Increase to cover increased costs
Oils Various (55 gallon drum)	\$ 25.00	no change
Organic Peroxides (per pound)	\$ 8.40	7 to 8.4 - 20% disposal price increase
