NOTICE IS HEREBY GIVEN, that on November 29, 2023, the Snohomish County Council approved the following ordinances relating to:

# APPROVING AND AUTHORIZING THE COUNTY EXECUTIVE TO EXECUTE THE INTERLOCAL AGREEMENTS BETWEEN SNOHOMISH COUNTY AND THE VARIOUS CITIES AND TOWNS FOR ACTIVITIES RELATED TO SOLID WASTE IN SNOHOMISH COUNTY

<u>Summary:</u> Since 1990, the cities and towns within Snohomish County have entered into interlocal agreements (ILAs) to participate in the County's Comprehensive Solid Waste Management Plan and the County's Solid Waste System. Through this agreement, the County provides disposal sites and the cities and towns designate those sites for the disposal of solid waste generated within their borders. There are 19 various cities and towns within Snohomish County that currently have ILAs for disposal of solid waste with Snohomish County Public Works Solid Waste Division that expire on December 31, 2023. A new 15-year agreement has been negotiated with each individual jurisdiction, and if approved, will be in effect upon execution through December 31, 2038. The new agreements are substantively similar to the prior agreements. The 19 proposed ILAs contain the same language, with the exception of the City of Everett, which required a slight language change for indemnification.
