Subject: Indigent Defense Contracts – Conflict Pannel

Scope:

Approve six (6) agreements with outside counsel to provide indigent defense services when there is a conflict with the County's primary contractor, the Snohomish County Public Defender's Association. The most notable change from prior year contracts is found in Schedule B, Compensation which increases the per hour rate for Superior and District Court miscellaneous proceedings; miscellaneous criminal proceedings; RALJ; and child representation in dependency proceedings. Additionally, these contracts include all indigent defense services under one contract instead of multiple contracts with the same attorney for different types of cases.

Four of the six contracts are with new to the County attorney's. At the request of the department, initial contracts (highlighted) are being requested for final consideration on January 15th, with the renewal contracts going the January 22nd.

The total amount appropriated in the 2025-2026 budget across the DAC's listed in the ECAF is \$5.6M (conflict panel plus child dependency and a superior court DAC). For conflict/indigent defense contracts over the 2025-2026 contract period:

<u>Authority Granted:</u> All six motions provide the Executive the following authority:

- Execute the contracts; and
- Execute any amendments.

<u>Background:</u> The <u>Sixth Amendment</u> of the United States Constitution states that the accused has the right to the assistance of counsel for their defense in criminal prosecutions. As not every defendant can afford an attorney, in 1989 Washington State implemented <u>Chapter 409</u> (<u>RCW 10.101</u>) stating that "legal representation should be provided for indigent persons and persons who are indigent and able to contribute." This chapter also requires counties and cities to establish standards for the delivery of defense services to indigent defendants.

Since the enactment of <u>RCW 10.101</u>, the County has contracted with outside attorneys for legal services to indigent defendants through the courts¹, and then in 2000 under the Office of Public Defense upon its creation². Today, the largest contract is with the Snohomish County Public Defender Association (PDA), who is the main provider of legal services to indigent defendants in the County. When PDA has a conflict of interest in a case, the case is deferred to one of the County's other contracts that specifically picks up cases where there is a conflict of interest between the defendant and the PDA.
