AUTHORIZING APPROVAL OF AMENDMENT NO. 2 TO THE AGREEMENT FOR
PROFESSIONAL SERVICES WITH SHANNON & WILSON, INC. FOR MEADOWDALE
BEACH PARK AND ESTUARY RESTORATION PROJECT

WHEREAS, construction of the Meadowdale Beach Park and Estuary Project commenced in spring of 2021; and

WHEREAS, Motion 20-110 authorized approval of the Agreement of Professional Services with Shannon & Wilson, Inc., selected through the county's Request for Qualifications process (RFQ -002-21SB), to provide geotechnical related construction management services for a fee of \$399,437.00 (Three Hundred Ninety-Nine, Four Hundred Thirty-Seven Dollars); and

WHEREAS, Motion 21-335 authorized approval of Amendment No. 1 with Shannon & Wilson, Inc., for additional construction observation and geotechnical engineering related services associated with the access road stabilization, City of Edmonds right of way use permit, and BNSF pile driving; and

WHEREAS, Amendment No. 2 has been negotiated with Shannon & Wilson, Inc., and includes additional construction observation and geotechnical engineering related services associated with design and installation of a retaining wall along the ADA-limited access road, recommendations for foundation for the new picnic shelter, additional coordination needed for the temporary shoring installation and BNSF bridge installation, oversight and sampling for contamination-related issues and increased project management services due to County staff changes; and

WHEREAS, the total amount of Amendment No. 2 is not to exceed \$189,280 (One Hundred, Eighty-Nine Thousand, Two Hundred and Eighty Dollars) for a total contract amount not to exceed \$687,197.00 (Six Hundred Eighty-Seven Thousand, One Hundred Ninety-Seven Dollars); and

WHEREAS, funding for Meadowdale Beach Park and Estuary Restoration Project ("the Project") has been included in the Snohomish County Capital Improvement Program (CIP) since 2016; and

WHEREAS, funding for the Project includes awards from six (6) grants totaling \$6,704,000.00 (Six Million, Seven Hundred and Four Thousand Dollars) with the remaining \$8,296,000.00 (Eight Million, Two Hundred and Ninety-Six Thousand Dollars) from REET 2 funding and tax-exempt bond funds as approved in Motion 20-401;

NOW, THEREFORE, ON MOTION, the Snohomish County Council hereby approves and authorizes the County Executive to sign Amendment No. 2 to the Agreement for Professional Services with Shannon & Wilson, Inc.
