APPROVING THE PUBLIC FACILITY DISTRICT OF EDMONDS  
INTERLOCAL AGREEMENT CLFR-036c

WHEREAS, Snohomish County has secured Coronavirus Local Fiscal Recovery (CLFR) grant funds under the federal American Rescue Plan Act (ARPA); and

WHEREAS, the Executive Office of Snohomish County created the Office of Recovery & Resilience (ORR) to aid in the distribution of the ARPA funds; and

WHEREAS, both the County and the Public Facility District (PFD) of Edmonds are public agencies under chapter 39.34 RCW; and; and

WHEREAS, RCW 36.01.085 states that economic development programs are a public purpose for counties in Washington state; and

WHEREAS, chapter 53.04 RCW authorizes the PFD of Edmonds to operate rail or motor vehicle transfer and terminal facilities, water transfer and terminal facilities, air transfer and terminal facilities, or any combination of such transfer and terminal facilities, and other commercial transportation, transfer, handling, storage and terminal facilities, and industrial improvements; and

WHEREAS, the County recognizes the PFD of Edmonds is important to economic development in Snohomish County; and

WHEREAS, the County desires to provide the PFD of Edmonds with \$250,000 as a subrecipient of federal funds to provide government services in compliance with chapter 53.04 RCW.

NOW, THEREFORE, BE IT ORDAINED:

Section 1. The Snohomish County Council approves the PFD of Edmonds Interlocal Agreement (for the period January 1, 2022, to December 31, 2023) in the amount of \$250,000 and authorizes the County Executive to sign the Agreement.

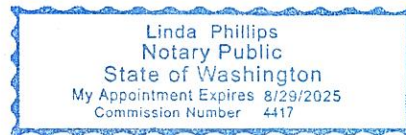
