- If the quoted hours do not cover the services required, an additional service request will be issued.

#### Work Order Details:

- All fees still owed on the original quote must be paid upon reaching milestones.

### **Service Warranty:**

- Customer agrees to pay UKG for all fees due pursuant to this SRO plus any applicable federal, state, and local taxes.
